INDEMNIFICATION: The Purchaser and/or Representative listed on the reverse side hereof agrees to indemnify, defend (including all legal, attorney costs, fees and judgments) and shall hold harmless the Archway Memorial Chapel (Funeral Home), It's Officers, Members, Employees or Contractors or its Agents from any claims, lawsuits or causes of action, including, but not limited to, physical or bodily damage or death arising or related in any respect to the caring for, holding, providing public or private visitations, funeral services, cremations or any disposition including any pandemic but not limited to transportation of the deceased, family members, attendees as well as providing or allowing for casket or urn to be handled or carried by pallbearers for ANY participant, invited as a guest or not, in any events, services, procession and transportation of the deceased, family or whether invited as guest or not in the providing of any and all services of the deceased at all times by the Funeral Home including but not limited to leading processions to any cemetery.

Purchaser and/or Representative understands that the funeral procession is not required and therefore has informed guest or participants the address of the Cemetery/Crematory where the final disposition will take place. The Funeral Home reserves the right to pause, stop or reschedule the visitation, funeral or disposition or any services at any time should Representative, Purchaser or any participants or attendees invited or not, do not follow instructions given by said funeral home or any of its staff, employees or agents or payment is not received.

All above Indemnification, Defend and Hold Harmless shall also encompass the following:

Funeral Home or AMCLLC makes no warranties or representations concerning the products sold herein. The only warranties, expressed or implied, granted in connection with the products sold with this funeral service, are the expressed written warranties, if any, extended by the manufacturers thereof. The Funeral home and AMCLLC hereby expressly disclaims all warranties, expressed or implied, relating to all such products, including, but not limited to, the implied warranties of merchantability and fitness for a particular purpose.

Purchaser authorizes the Funeral Home to post the Decedent's obituary on the Funeral Home's website, Face-book page and/or other websites on the Internet that list obituary and death notices. The REPRESENTATIVE hereby releases the FUNERAL HOME from all liability that may arise from the posting of the obituary.

Purchaser and/or Representative hereby grants and protects and indemnifies and grants to the FUNERAL HOME the license to scan, copy and/or use the PHOTOGRAPHS in a funeral program, announcement, website, social media, tribute video, DVD, or other tribute presentations of the DECEDENT, including live streaming or webcasting (which can not be guaranteed by FUNERAL HOME) of any provided services from any location for viewing on any of the previous above platforms including but not limited to Facebook, etc.

PUBLIC VIEWING: If the REPRESENTATIVE has directed the FUNERAL HOME to arrange and conduct an open casket viewing of the DECEDENT. The remains of the DECEDENT may be viewed by anyone who is present at the viewing service. If Private or limited arrangements have been made, Representative shall provide the funeral home a written list of all attendees 24 hours prior to the scheduled event or service.

RELEASE: The REPRESENTATIVE acknowledges the risk than an attendee may take unauthorized photographs or videos of the remains of the DECEDENT and that the FUNERAL HOME cannot guarantee such photographs or videos will not be taken despite efforts to prohibit or discourage any photographs or videos. The REPRESENTATIVE releases FUNERAL HOME from any and all claims arising out of the unauthorized photography or videotaping of the remains of the DECEDENT, including but not limited to the unauthorized posting of such photographs or images or live streaming, webcasting, online, etc. By signing and initialing this form, the REPRESENTATIVE acknowledges and agrees that the FUNERAL HOME has advised the REPRESENTATIVE that it is not possible to insure that an attendee at the services where the remains are whether viewed or not, will not photograph or video the remains and has read and understood ALL of the above agreements.

Funeral Homes requires all arrangements for the full payment of the funeral be finalized prior to the Funeral Home making any arrangements to conduct a visitation, funeral or memorial or cremation services. As the person legally responsible for payment and authority to arrange for services, please place your initials beside the appropriate payment option that you have selected to pay the funeral expenses. This will indicate the method you have selected to pay for the funeral goods and services listed on the Funeral Purchase Contract.

Insurance Assignment: Proceeds from one or more insurance policies in force for 2 years or more can be assigned to Funeral Home for all or a portion of the funeral expenses. All policies MUST be verified as "In-Force" and the amount payable before any insurance will be accepted as payment of funeral expenses. An insurance claims processing fee of 10% will be added to the funeral bill to compensate the Funeral Home for processing the insurance claim. The Purchaser(s) signing this document will be responsible for any shortfall in the funeral bill if the insurance proceeds do not fully pay all funeral expenses.

The Purchaser and/or Representative understands and acknowledges that if a rental casket is to be used in the funeral services of the DECEDENT, it may have been used previously by the FUNERAL HOME. The REPRESENTATIVE further understands and acknowledges that immediately prior to the final disposition of the remains of the DECEDENT, the FUNERAL HOME may reclaim the rental casket and will place the remains of the DECEDENT in a different or fiberboard container for such disposition. Regardless of the receiving of Cash Advances or not, to forward to such Cemetery or any item listed, Funeral Home shall not be and is not responsible for any items, product or location(s), any conditions, regulations, warranties or agreements at ANY cemetery or disposition site or ANY third party items used for the DECEDENT.
